THE STRATEGIC RELEVANCE OF A EUROPEAN PERSPECTIVE FOR BELARUS AND THE EU

BACKGROUND

Its pervasive dependence on Russia has driven Belarus to the abyss. A convincing Western alternative needs to be prepared. United Europe will be more secure, more sustainable, more prosperous with Belarus returning to "the family". The groundwork for this starts in the minds of the people and decision makers, but also requires concrete preparations.

THE AIMS OF THE CONFERENCE-WORKSHOP:

- To identify the current and foreseeable interests of the EU towards Belarus; the interests
 of (pro-democratic) Belarus(ians) towards the EU and ways to match them in the best possible
 way
- To work out a clear narrative and convincing messaging on the European character of Belarus and the strategic relevance of its "European perspective" (for both sides) as a credible and attractive geopolitical alternative
 - A) for decision makers in the EU (and broader West)
 - B) for Belarusians at home
- To identify key fields in which pro-democratic Belarusians and Western decision makers can take concrete action to
 - A) make the European alternative more practicable and credible
 - B) prepare for a "window of opportunity" (support mechanisms etc)
 - C) empower pro-democratic Belarusians in exile and overcome existing challenges.

There has to be a sync of interests of pro-democratic Belarusians and Western decision makers to reach a strong, joint positive narrative around European Belarus.
